Reports from Town Board Members and Department Heads

Councilwoman Potter-Juda commends everyone for their hard work. All the Department Heads pulled together and did a great job. She appreciates the patience of the community with all the snow. Thanks to everyone in B & G and Highway for all their hard work.

Councilman Quinn thanks everyone for all their hard work. He was probably one of the last streets to be plowed, so there was no favoritism. He was sick for the last meeting and went away with his family only to come home to all the snow. He was in contact with Mr. Best on a daily basis and was available by phone to anyone that needed him.

Supervisor Walters comments that in parts of the Town there was 90 inches of snow. The Town of Hamburg had the highest average total snowfall of any Town in Erie County. Superintendent Best started procuring outside sources as early as Tuesday into Wednesday morning of the storm. They had a difficult time on Wednesday removing vehicles off of the main arteries in the Town. They couldn't even reach the majority of sub-divisions due to the stranded vehicles and tractor trailers. They towed over 100 vehicles so the plows and high lifts could do their job. The travel ban for the Town of Hamburg was lifted simultaneously with Orchard Park and Evans and was lifted before the Cities of Lackawanna and Buffalo. 100% of our roads were passable, by two vehicles, by Sunday afternoon. At that time Orchard Park, Evans, West Seneca, Lackawanna, the Town of Aurora and Buffalo were still working on enlarging their roads so two vehicles could pass. This morning all the Town buildings were open for business with the exception of the Adult Day Care Center. The reason that was not open was the timing to get the order into the County for the meals. Hamburg, Frontier, and Orchard Park schools remain closed until December 1st, which gives an idea of just how catastrophic the snowstorm was. The town requested their first piece of equipment for snow removal at 10:05 am on Tuesday morning through the DLAN system, they were on top of it right away. Unfortunately because of the fact that the priorities were put on the City of Buffalo, the Town of Hamburg did not start receiving equipment until Friday evening. He is not criticizing those decisions. He is only pointing out the reality. Even though our roads were clogged with snow the emergency crews were out, Fire, EMS and Police, and they delivered hundreds of prescriptions to people who were stranded. He thanks the Highway and B & G Departments, the Police Department, Dispatch and Emergency Services. He thanks the Town of Amherst for sending six Police Officers, a Dispatcher and various vehicles. They had Officers from the DEC help along with the National Guard, State Police and County Sheriffs. The Hamburg Snowmobile Club and WNY Snowmobile Club volunteered their services. Great Lakes Concrete, Union Concrete, the NYS DOT and the Town of Webster New York sent all available plows and worked day and night to help. All Nine Volunteer Fire Companies plus other mutual aide crews came from all over New York State to help. Wegmans donated thousands of dollars in food to our emergency operation center. Also, Savory's, Blasdell Pizza, Peg's Place and the list goes on and on. He wants to point out how the community came together. There are hundreds of stories throughout the Town. He thanks Sean Crotty, Glen Zawariucha, Paul Randall, Fire Coordinators John Carlin and Paul Wilson, Chief Williams, all the Command Officers and all the men and women in that Department, Tom Best, Jay Collard, Ray Pawlowski, Pat Ryan and Charlie Coughlin. The Dispatch Office had more calls in the past week than they normally get in an average month. Kurt Allen, Joe Boncore, Jim Eberhardt from the Building Inspection Department were dealing with compromised building

structures. They were experiencing IT problems and sent a vehicle for Donna Gavin, who came in, no questions asked. The list goes on and on. The snow stopped Thursday and by Sunday afternoon every street in the Town was cleared and no one was killed. Everyone did a tremendous job and he is proud to be part of that team. He gives kudos to everyone involved.

Gerard Kapsiak, Town Engineer, reports that he checked on the Railroad Quiet Zones installations at Rogers Road and Pleasant Ave. to see how they made it through the storm. He is happy to report that they made it through without any damage from the snowplows or traffic and that the Railroad crossing gates and flashing lights remain intact. This was the first test for the installations and so far so good.

Supervisor Walters responds that if they can pass this test they can pass any test.

Highway Superintendent Best sends out kudos to the men and women in the Highway and B & G Department for their hard work and dedication in the midst of a truly insane snowstorm. This storm has been rated as number 4 ever to hit North America, only behind the Blizzard of '77. Thank you everyone in Town, they did a great job.

Supervisor Walters comments that he also wanted to point out that the first night of the storm, with all the stranded vehicles, they were able to rescue all the people stranded and put them in the Fire Companies. As the second day started they needed to get those people to shelters. The Town Senior Services Department has a couple of vans and they thought that would be the way to get them out. They called the Director, Marty Denecke, and he said he was on his way and he personally picked up those people and got them safely to the shelter.

Marty Denecke, Director of Youth, Recreation and Senior Services reports that as they approach the Holiday Season he would like to remind everyone that they will once again be involved in the Western New York Holiday Partnership. This is a coordinated effort to collect toys for the needy. The Hamburg Youth Bureau is in charge of the Hamburg vicinity. There will be toy collection bins at all Town facilities including Hamburg Town Hall. They will accept any businesses who would like to partner with them on this program. Last year they served nearly 100 families. For the Adult Day Care Center they have an entertainment fund that is supplemented by the sale of F.I.R.S.T. gift certificates. This stands for Friendly Independent Restaurants in the South Towns. They have \$10.00 gift certificates and for every \$10.00 the Adult Day Care receives \$3.00 back. Finally, they are getting very close to opening up their new building on Southwestern. Although the Administrative wing has been open for almost a year the renovations are nearly complete and the building is spectacular. The gym is open for recreational programming.

Kurt Allen, Supervising Code Enforcement Officer, comments that he too is grateful for his Building Inspection team. They all showed up, during the storm, and did a difficult job handling damage assessment and inspections. They are not done yet. There is a lot of structure damage and they are dealing with the rebuilding efforts. He encourages anyone who has structure damage to contact his department. They had over 100 inspections over a three day period. They are now regulating the reconstruction period through a permit process to insure that everyone is in compliance with the proper codes.

Thom Taylor, Sr. Public Safety Dispatcher, thanks his employees for all their dedication over the last six days. He also wants to thank their families for allowing them to spend all that time to do their job. To the citizens, he apologizes if anyone was short with them on the phone, and would like to share some facts. From Tuesday (11-18) at midnight going to Sunday (11-23) at midnight the dispatch office handled 5,993 administrative phone calls, along with another 1,352 911 calls which is more than one months' worth of 911 calls in 6 days. They dispatched a total of 1,965 Police and Fire complaints and that does not count all the undocumented calls. He had dispatchers trying to call neighbors to help clear out vents for furnaces. He lived through the blizzard of '77 and didn't think he would ever see one that would top it and he feels he did. Kudos to his staff and their families and thank you to everyone for their assistance.

Chief Williams thanks his Officers for the work they did. He doesn't think everyone understands that his officers didn't get their streets plowed first and so if they couldn't make it to work they walked until they could find someone to pick them up. They got home the same way. He had officers that worked 12 to 14 hours with wet shoes and wet socks. He wanted to send them home and they said that they were fine they wanted to stay and help. They are what make the Town of Hamburg Police Department so great. They have a genuine interest and care about this community. No one has recognized the tow operators as yet. They went out and towed 100 vehicles in that horrible weather trying to get the roads open. If they hadn't gotten the vehicles off the road it would have made it much harder to get the roads open. All the extra Police Officers and National Guard are still there helping out. He thanks his clerical staff and the emergency management team. It was hard to document all the calls. However, from Monday (11-17) at 9:30 pm to 12:00 pm today (11-14) they did over 1,075 documented calls. Last year at that same time they did 498 calls and a lot of those are traffic stops which they didn't have. His command staff said that he should take the 1,075 documented calls and triple or quadruple it.

Sean Crotty, Emergency Management Coordinator, comments that he would like to come up with supporting documents like the dispatchers and police had, but they still have 25 additional mutual aide crews available, in addition to our volunteer firemen, if there is an emergency. In all, they had 123 mutual aide units from across the state. It is a Fraternity, a brother and sisterhood, and they remember when the Town of Hamburg went to the ice storms in the north country, they remember when we responded to September 11th and a lot of the departments are paying back. In addition to all the dedication of all the workers in the Town of Hamburg they had a great core of people coming from across the state. Although Superintendent Best couldn't get to it with a plow, they had every inch of the Town covered. They had trail groomers from Boston that were available immediately. They were the reassurance that they could get anywhere In Town. So, although they couldn't get there by plow, they had alternative methods, a Plan B, to get to people. Between the Code Red messages and Twitter and the social media they were able to monitor what was going on throughout the Town. He echoes the sentiments of everyone in their thanks to the public and everyone involved.

Supervisor Walters wants to add a thank you to Mayor Tom Moses and Mayor Mike Petri from the Village of Hamburg and Village of Blasdell and their teams. There was a lot of coordination between the town and both villages to get the job done.

Business from the Floor

Dennis Chapman questions where they stand on resolution 20 concerning the Police Commissioner. Is the Town in compliance with the law?

Supervisor Walters responds yes we are.

Maryann Harris, Carnegie area, comments that unfortunately her husband was one of the people that didn't get his medication. Finally on Saturday a friend that is a volunteer fireman was able to get out and get it for them. She has friends in the Four Seasons area that she knows didn't get plowed until after she did. She questions do they have certain areas or zones when they are plowing?

Supervisor Walters responds that the Town does have plow routes that they normally travel. They can normally get the entire Town completed in a 6-8 hours. However, he was traveling by a one mile long street and they were just getting started with snow removal and when he passed it almost 4 hours later they were just finishing. So, it took almost four hours to complete one mile. That is why it took so long to complete the entire Town.

Sean Crotty responds to the medicine issue. They had volumes of calls for medical issues. They had to prioritize and dialysis patients came first. Then a doctor had to go through each medication request and prioritize them.

Ms. Harris responds that she understands and they did get the medication they needed.
