- 1.) ARMOR TAP ROOM, TSAB HAS RECEIVED ADDITIONAL INFORMATION FROM M. TUFILLARO . WITH THE ACQUISITION OF ADDITIONAL PROPERTY ADJACENT TO THE TAP ROOM TO BE UTILIZED FOR PARKING, THIS ADDITION SHOULD REDUCE PEDESTRIAN TRAFFIC. THEREFORE IT IS TSAB DECISION TO ENDORSE THE PROPOSED BLACK ROUTE BY COUNTY HIGHWAYS AND THE TOWNS PLANNING BOARD.
